- 1-1 The Ref. No is a part location number composed of two (2) numbers. The first digit refers to the section number and the second digit to the consecutive number. Using the Ref. No., it is easy to find parts quickly from anywhere in the parts list.
- 1-2 The initials found in the Remarks column refer to the names of countries. Please find the corresponding countries in the table below. If there is no initial, it is a standard part.
